

## **INSTRUCTIONS FOR INFORMATION**

### **PURSUANT TO SECTION 810 CRIMINAL CODE OF CANADA**

Person(s) wishing a Section 810 Order should clearly fill in the blanks on the Information.

In the first space (1) fill in your full name.

In the second space (2) fill in the name of the town or city where you live.

In the third space (3) fill in the name of the defendant.

In the fourth space (4) again fill in the name of the defendant.

In the fifth space (5) fill in the first date on which the defendant's actions commenced.

In the sixth space (6) fill in the last date on which the defendant's actions occurred.

In the seventh space (7) fill in the name of the town or city where the defendant's actions occurred.

In the eighth space (8) briefly describe the actions of the defendant which give rise to your fears.

In the ninth space (9) fill in the name of the defendant.

When the form is completed swear to the Information before a Justice of the Peace and sign your full name.

## **PEACE BOND CONDITIONS**
