The following Practice Directive is published pursuant to Rule 1.04 of the *Criminal Proceedings Rules of the Supreme Court of Newfoundland and Labrador*.

### PUBLICATION BAN ORDERS - FORMS

#### Background and Purpose

1. Members of the public and the media have noted that it is sometimes difficult to quickly find information regarding whether there is a publication ban in effect in a given Court proceeding. And even where a person knows that a publication ban order is in place, it may not be obvious, on the face of a Court file, what authority was relied upon in making the order, and what information (names, identities, etc.) is covered by the order.
2. In an effort to ensure that the media, the public, and other justice system participants are aware of applicable publication restrictions, their scope, and the authority under which they are made, the Court issues the following Practice Directive, providing a number of fillable Publication Ban Order Forms for use in criminal proceedings.

#### Practice Note:

3. Where counsel is seeking a publication ban order pursuant to s. 486.4, 486.5, or 517(1) of the *Criminal Code*, they should file a draft order, using the appropriate form attached to this Practice Directive, with the necessary information filled in.

4. The judge may then review the draft order and, if appropriate, approve its form or require amendments thereto.

(b) if the accused in respect of whom the proceedings are held is tried or committed for trial, the trial is ended.

Every person who fails to comply with an order made under s. 517(1) is guilty of an offence punishable on summary conviction.
