NOTE: By the oath or affirmation which you have taken you are bound to render a true account of your administration whenever required to do so. At such time, you are required to file in the Registry of the Supreme Court a statement of account duly verified under your oath or affirmation showing how the estate has been dealt with.

SECTION 129 OF THE JUDICATURE ACT, 1986 PROVIDES AS FOLLOWS:

- "129. Every person to whom letters of probate or administration are granted shall, within one year after the issuance of the grant, file in the Registry
 - (a) a full inventory and valuation of the estate of or to which the deceased was possessed or entitled to at the time of the death of the deceased;
 - (b) a full statement of the estate that has come into that person's hands or into the hands of any other person by that person's order;
 - (c) a full statement of disbursements made by that person on account of that funeral expenses, debts and estate; and
 - (d) a full statement of the estate then outstanding or undisposed of."
